

STATEMENT ON PERSONAL DATA PROCESSING

Metalco s.r.l. (hereinafter the “Company”) makes this statement pursuant to and in accordance with Art. 13 of Regulation (EU) 2016/679 (hereinafter “GDPR”), on the protection of natural persons with regard to the processing of their personal data, to inform you of the purposes and methods for processing any personal data that you may provide while browsing this website (hereinafter the “Website”).

It should be specified that this statement refers only to the Website and not to any third party websites that may be reached by links contained within it.

CATEGORIES OF DATA PROCESSED

Browsing data

The computer systems and software procedures used to operate the website acquire, during their normal operation, certain personal data whose transmission is implicit in the Internet communication protocols. This information is not collected to be associated with identified data subjects, but by its very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes, for example, IP addresses or domain names of computers used by users who connect to the website, URIs (Uniform Resource Identifiers) of requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in reply, the numerical code indicating the status of the response from the server (successful, error, etc.) and other parameters regarding the user's operating system and IT environment. These data are used for the sole purpose of obtaining anonymous statistical information on website use and to check its correct functioning and are deleted immediately after processing.

Data provided voluntarily by the User

The optional, explicit and voluntary sending of email to the addresses indicated on the website involves the subsequent acquisition of the sender's email address, which is necessary in order to respond to requests, as well as any other personal data included in the message. Specific summary statements are given or displayed on the Website sections set aside for particular on-demand services and subject, where necessary, to the data subject's consent.

Cookies

In compliance with the Decision of the Italian Data Protection Authority No. 229, containing the “Simplified Arrangements to Provide Information and Obtain Consent Regarding Cookies” of 8 May 2014, the Company informs users about the use of browsing cookies on this Website. It should be specified that this statement refers only to the Website and not to any third party websites that may be reached by links contained within it.

What are cookies?

A cookie is a small file that is sent to the browser being used and saved on your device when you visit a website like www.metalco.it. Cookies enable the Website to function efficiently and improve its performance. They provide information to the owner of the Website for statistical or advertising purposes, mainly to customise your browsing experience by remembering your preferences. The Website uses different types of first party cookies (prepared and managed by Metalco s.r.l.) and third party cookies (prepared and managed by third parties based on their own privacy policies and not under the control of Metalco s.r.l.). An explanatory table is given below.

TYPE OF COOKIES	FUNCTION
technical cookies (session or browsing)	These ensure normal browsing and use of the website and they are therefore intended to streamline and optimise browsing on the website.
function cookies	These are absolutely necessary in order to provide the services expressly requested by the user.

first party analytical cookies	These are used and set up by Metalco s.r.l. exclusively in order to collect information in anonymous and aggregate form about the number of users and how they browse the website.
third party analytical cookies (e.g. Google Analytics)	Metalco s.r.l. has adopted appropriate tools to ensure that processing with these cookies is carried out for statistical purposes only.

Enabling and disabling cookies in the browser.

The majority of browsers are set up to accept, control or, if necessary, disable cookies through settings. We remind you, however, that disabling browsing or function cookies may result in poor website function and/or restrict the service we offer.

DATA DISCLOSURE AND CATEGORIES OF RECIPIENTS

Solely for the purposes specified above, all the data collected and processed may be disclosed to internal figures authorised to carry out processing as part of their duties, and to external parties to whom it may be necessary to disclose the data. These recipients, where they process data on behalf of the Company, will be designated as data processors under an appropriate contract or other legal document.

TRANSFER OF DATA TO A THIRD COUNTRY AND/OR INTERNATIONAL ORGANISATION

Your personal data will not be transferred to third countries outside the EU.

RIGHTS OF DATA SUBJECTS

You have the right (see articles 15 -22 of the GDPR) to request our Company for access to your personal data and to rectify them if they are inaccurate, delete them or restrict processing, and to obtain portability of the data provided by you only if subject to automated processing based on your consent or on a contract. You also have the right to withdraw the consent given for the processing purposes that require it without affecting the lawfulness of processing based on consent before its withdrawal. You also have the right to lodge a complaint with the competent authority (Italian Data Protection Authority).
